Important instructions for e-auction process.

- 1. The bidding documents consisting of qualifying information, eligibility, criteria, set of terms and conditions and other details can be seen/ downloaded from the departmental website www.jktenderes.gov.in as per schedule of dates given in e-auction notice.
- 2. Bids must be accompanied with cost of bidding document of Rs. 500/- in the shape of demand draft in favor of Chief Accounts Officer, Estates Department or GR to be remitted in Treasury under major Head 0216- Housing and earnest money in shape of CDR/FDR pledged to Chief Accounts Officer Estates Department, without which the bids will not be entertained.
- 3. The date and time of opening of bids shall be as per e-auction notice notified on web site www.jktenders.gov.in and conveyed to the bidders automatically. The bids of responsive bidders shall be opened online on same web site in the office of Director Estates Jammu at Civil Secretariat Jammu.
- 4. The earnest money shall be forfeited, if:
- a. Any bidder withdraws his/her bid during the period of bid validity or makes any modification in the terms and conditions of the bid document.
- b. Failure of successful bidder to adhere to any conditions of e-auction notice.
 - . Unsatisfactory services are provided by the bidder.
- 5. Bidders are advised to download bid submission manual from the "Downloads" option as well as from "Tenders Manual Kit" on website www.jktenders.gov.in so as to acquaint with the bid submission process.
- 6. To participate in Bid process, bidders have to get "Digital Signature certificate (DSC)' as per Information Technology Act-2000. Bidders can get digital certificate from any approved vendor as per his/her convenience.
- 7. The bidders have to submit their bids online in electronic format with digital signature. No bid will be accepted in physical form.
- 8. Bids will be opened online as per time schedule mentioned in the e-auction notice.
- 9. "Bidders must ensure to upload scanned copies of all necessary documents including earnest money and bid document fee. However, in case of any clarification, the bidders shall have to produce original documents in support of soft copies if need arises."
- 10. The earnest money in favour of unsuccessful/ Non-responsive bidders shall be released at the earliest after the end of bidding process.
